# TERMS OF SERVICE AGREEMENT

PLEASE READ THE FOLLOWING TERMS OF USE AGREEMENT CAREFULLY. BY ACCESSING OR USING OUR SITES AND OUR SERVICES, YOU HEREBY AGREE TO BE BOUND BY THE TERMS AND ALL TERMS INCORPORATED HEREIN BY REFERENCE. IF YOU DO NOT EXPRESSLY AGREE TO ALL THE TERMS AND CONDITIONS, THEN PLEASE DO NOT ACCESS, OR USE OUR SITES OR OUR SERVICES. THIS TERMS OF SERVICE AGREEMENT IS EFFECTIVE AS OF 06/19/2023.

# **ACCEPTANCE OF TERMS**

The following Terms of Service Agreement (the "TOS") is a legally binding agreement that shall govern the relationship with our users and others which may interact or interface with CyberHoot, LLC., located at 21 Mary Batchelder Rd., Hampton, New Hampshire 03842, and our subsidiaries and affiliates, in association with the use of the CyberHoot, LLC website, which includes cyberhoot.com (the "Site") and its Services, which shall be defined below.

# PAYMENT REQUIREMENTS

CyberHoot requires all users to enter credit card or ACH information for billing purposes into the site upon registration. CyberHoot provides a 30-day grace period for payments and at its sole discretion may extend that for further evaluation when necessary to secure new business from a direct client or reseller.

CyberHoot has built automated invoicing into our system to simplify the cost structure of providing services to our end user community. By accepting these terms of service, you are acknowledging your willingness to be automatically billed monthly based upon the total and highest user count captured by CyberHoot monthly. Manipulating user counts to avoid payments are considered a violation of these TOS and CyberHoot may, at its sole discretion terminate Services.

Alternatively, you may be charged a flat rate by special agreement with CyberHoot.

All charges are final and will not be refunded. Failure to pay on 3 billing dates, not necessarily in succession, will lead to a forfeit of your environment and it will be shut down and your data deleted.

All CyberHoot users and environments are at will and may be canceled at any time without penalty.

Cyberhoot.com is a subscription-based policy, video, and assessment management website which automates the distribution, collection, and compliance reporting of employee acceptance to employee governance policies, awareness training videos, and assessments and/or surveys.

#### FREE VIDEO CONTENT

CyberHoot is an LMS platform that curates' videos, provides access to a large policy and process library, as well as a library of assessments and surveys for use by our clients. It is important to note that all video content within CyberHoot is free for use on our public website as well as on YouTube(tm) and Vimeo(tm) websites (where appropriate). CyberHoot does not charge for this video content in our commercial product. We give both our curated content and self-produced content away for free on our public website in compliance with YouTube and Creative Commons licensing for embedded content. We do this to raise awareness on a variety of topics that are important to Small and Medium sized businesses. All CyberHoot paid services are exclusively for our LMS Framework which manages launching, tracking, reporting on compliance with Policy, Video, and Assessment assignments to employees.

All visitors to our site, despite whether they are registered or not, shall be deemed as "users" of the herein contained Services provided for this TOS. Once an individual registers for our Services, through the process of creating an account, the user shall then be considered a "member."

The user and/or member acknowledges and agrees that the Services provided and made available through our website and applications, which may include some mobile applications and that those applications may be made available on various social media networking sites and numerous other platforms and downloadable programs, are the sole property of CyberHoot, LLC. At its discretion, CyberHoot, LLC. may offer additional website Services and/or products, or update, modify or revise any current content and Services, and this Agreement shall apply to all additional Services and/or products and all updated, modified, or revised Services unless otherwise stipulated. CyberHoot, LLC. does hereby reserve the right to cancel and cease offering any of the Services and/or products.
